In mayoral field, coolness toward St. Patrick's parade

Boston's next mayor likely will not march in South Boston's St. Patrick's Day parade until gays and lesbians are allowed to participate, and would oppose a Walmart opening within the city limits, according to a Globe survey.

But the 12 candidates are fractured over whether to lift the moratorium on independent charter schools, on how many Bostonians should be allowed to vote on a proposed East Boston casino, and whether term limits should apply to the mayor.

The Globe questionnaire sizes up candidates' views on a range of issues. On only one did the entire field stray noticeably from the legacy of Thomas M. Menino. Asked whether the city should allow developers to construct taller buildings, everyone who answered said yes.
