# Pair arrested after toddler found roaming in parking lot

A man and woman were arrested Friday after a 2-year-old boy they were baby-sitting was spotted running in traffic in the parking lot of a Cohasset strip mall, police said. Rohn C. Hess, 33, of Scituate, and Jennifer Fiori, 26, of Weymouth, were charged with reckless endangerment of a child, Cohasset Police said in a statement. They are scheduled to be arraigned Monday in Quincy District Court. They were arrested after a woman called police saying she had seen a man who appeared to be intoxicated roaming with a toddler around a strip mall parking lot on King Street, police said. The child was not harmed and was returned to his father in Dorchester later in the day, police said. The father told officers he had hired Fiori to baby-sit while he worked. Hess also will be charged with unlawful possession of high-capacity magazines after

officers found five military-style magazines, without ammunition, inside a bag with a state health card with his name on it, police said.
