# At least 93 employees made \$1m or more at Mass. nonprofits

At least 93 employees at tax-exempt nonprofits in Massachusetts made more than \$1 million in 2014, according to a review by the Wall Street Journal of newly released data from the Internal Revenue Service.

Many of the employees were executives at hospitals and colleges.

The Journal found that nationwide, at least 2,692 nonprofit employees made \$1 million or more in 2014, which was about a one-third higher than the number who made at least that much in 2011.

The national- and state-level counts of million-dollar earning nonprofit employees could be higher because the review was only of data for organizations that had filed their annual tax returns electronically as of Dec. 30.


And, the count of employees from Massachusetts organizations may also exclude nonprofits for which the state of incorporation field was left blank in data published by the Journal.

Compensation at nonprofits has been increasing over the years as the organizations have become more professional and adopted pay strategies from the corporate world, the Journal <u>reported</u>. That has drawn scrutiny from lawmakers because the organizations' tax-exempt status.

The highest pay nationally among nonprofit employees in 2014 was \$17.6 million in total compensation given to Anthony Tersigni, president and CEO of the Missouri-based hospital operator Ascension.

The highest pay among employees at Massachusetts nonprofits in 2014 was \$13.8 million in total compensation given to Jane L. Mendillo, the then-president and CEO of Harvard Management Company, which runs the university's massive endowment.

In fact, the top five highest-paid employees at Massachusetts nonprofits in 2014 worked at Harvard Management Company, which has <u>faced criticism</u> for its Wall Street pay levels.



The Globe has documented the high compensation for numerous individuals on the list, including the <a href="head of Combined Jewish Philanthropies of Greater Boston">head of Combined Jewish Philanthropies of Greater Boston</a>, the former presidents of <a href="head of Springfield">Springfield</a> College, Brandeis University, and the leaders of other area campuses and hospitals.

Other Massachusetts nonprofit employees that made \$1 million or more in 2014 included the president of the Broad Institute in Cambridge, as well as the former heads of the <u>Clark Art Institute</u> in Williamstown, the <u>Museum of Fine Arts</u> in Boston, and the Charles Stark Draper Laboratory in Cambridge.
